# **Acceptable Use Policy**

This Acceptable Use Policy ("AUP") applies to all users of YZ Pro Academy's Service. Violation may lead to suspension or termination of access.

### 1. Prohibited Activities

You agree not to engage in any of the following:

## 1. Illegal or Harmful Conduct

- Engaging in or facilitating any unlawful activity.
- Sharing instructions or facilitating the planning or execution of violent or non-violent wrongdoing.

## 2. Intellectual Property Violations

- Uploading, posting, or sharing content that infringes on copyrights, trademarks, or other proprietary rights.
- Distributing pirated course materials or proprietary tools.

### 3. Harassment and Hate Speech

- Harassing, threatening, or bullying others (instructors, staff, fellow users).
- Posting hate speech or discriminatory content targeting protected groups.

### 4. Spam and Unsolicited Communication

- Sending unsolicited promotional messages, spam, or chain letters via the Service's messaging tools or forums.
- Excessive off-topic posting or disruptive behavior in forums or group discussions.

### 5. Security Violations

- Attempting to probe, scan, or test the vulnerability of any system or network.
- Attempting to gain unauthorized access to any accounts, servers, or networks.

Uploading or distributing malware, viruses, or harmful code.

### 6. Misrepresentation and Fraud

- Misrepresenting your identity, qualifications, or affiliation.
- Using another person's account without permission.
- Falsely claiming certification or credentials obtained via our courses.

## 7. Automated or Scraping Activities

- Using bots or automated scripts to access or scrape content from the Service, except via APIs we explicitly provide.
- Attempting to circumvent rate limits or access controls.

### 8. Inappropriate Content

- o Posting obscene, pornographic, or extremely graphic content.
- Sharing anything that is violent or otherwise not suitable for a professional learning environment.

#### 9. Interference with the Service

- Disrupting or interfering with the normal operation of the Service.
- Denial-of-service attacks or similar.

#### 10. Commercial Use Without Authorization

- Reselling or redistributing Content or course materials without explicit permission.
- Using the Service's platform to offer commercial services unless through approved partnerships.

## 2. Monitoring and Enforcement

 We may monitor activity and content on the Service to ensure compliance. We do not guarantee continuous monitoring but may investigate upon complaints or detected anomalies.

- If we believe you have violated this AUP, we may:
  - Issue warnings,
  - Temporarily suspend your access,
  - o Permanently terminate your Account,
  - Remove offending content,
  - Report to law enforcement if required.
